quality and aquatic habitat in Pecos. Mr. Lemke requested Commission approval on Resolution No EMC-2018-08-14 In support of the Upper Pecos Watershed Associations River keeper Program.

San Miguel County Information Technology Supervisor Diego Trujillo informed the Commission the owner of a Private driveway off NM Highway 484 in the El Pueblo Area petitioned the County to name the driveway leading to their resident. Per San Miguel County Ordinance No SMC-07-13-99-ORD-2, Section 4.1-C; proposed to San Miguel Board of County Commissioners please review and take appropriate action on road naming for, "any private road that provides access to three or more buildings and requires a name in order the health safety and welfare of the public." # 12. AMENDMENT TO GRANT NO. 16-A2485 COUNTY FAIRGROUNDS

San Miguel County Planning and Zoning Supervisor Alex Tafoya informed the Commission that during its May 9, 2018 the Board of County Commissioners accepted Legislative Appropriation Grant No 16-A2485 which will provide \$15,000 to plan, design, construct and renovate the exhibit hall roof insulation, including the purchase and installation of related equipment at the San Miguel County Fairgrounds. DFA-Local Government Division has advised the County that the Grant Agreement has been amended with changes to the pay request form, the notice of obligation form and the disregarding of the paper progress report form. Mr. Tafoya requested Commission accept the amended grant agreement and authorize Chairman Chris Najar to sign the grant agreement.

#### 13. RESOLUTION NO. 08-14-18-ICIP

San Miguel County Planning and Zoning Supervisor Alex Tafoya informed the Commission that San Miguel County has prepared its infrastructure Capital Improvement Plan (ICIP) for 2020-2024. Selection of top five (5) projects and adoption of the ICIP must be by resolution. The top five projects are as follows: 1. Gallinas Fire Truck, 2. Road Department Equipment Transportation Trailers, 3. Detention Center kitchen, laundry, and Security Improvements, 4. Sherriff Department Vehicles, 5. Public Works Department Equipment and vehicles. Mr. Tafoya requested Commission accept comment on projects to be included in the ICIP; (2) select the top five projects for legislative ranking; and (3) adopt Resolution No 08-14-18-ICIP.

## 14. AUTHORIZATION FOR CONTRACT NEGOTIATION-NCA ARCHITECTS

San Miguel County Planning & Zoning Supervisor Alex Tafoya informed the Commission San Miguel County issued RFP No. 2018-PZ for Professional Architectural Services as needed. SMC has received one proposal from NCA Architects of Albuquerque, New Mexico for various professional services to include architectural, engineering, mechanical, electrical, landscaping and land surveying. Mr. Tafoya requested the Commission authorize County staff to negotiate a contract with NCA Architects.

# 15. ADOPTION OF ORDINANCE NO. SMC-08-14-18

San Miguel County Planning & Zoning Supervisor Alex Tafoya informed the Commission that during the July 10, 2018 meeting, San County Commissioners adopted Resolution No SMC-07-10-18 this Resolution proposes an adoption of Ordinance No SMC-08-14-18. Mr. Tafoya requested the Commission hold and conduct a public hearing on the proposed Ordinance No. SMC-08-14-18, and adopt the Ordinance. San Miguel County Attorney Dave Romero swore in the following three individuals who spoke in behalf of Oakwood LLC, Chief Financial Officer Bob Witters, Vice-President Shiloh Old, and President David Old. The above three individuals for Oakwood LLC requested the Commission vote against Ordinance No SMC-08-14-18 until they resolve the issues with the County.

San Miguel County Commissioner Rock Ulibarri informed the Commission the County is at fault for falling out of compliance with the Federal Government USDA and not Oakwood LLC. Mr. Ulibarri stated that this was an issue from 11/2 year ago that did not get resolved.

# 16. GRANT AWARD IN THE AMOUNT OF \$8,045.00 FOR THE GARDENING PROGRAM AT THE SAN MIGUEL COUNTY DETENTION CENTER

San Miguel County Warden Matthew Elwell informed the Commission the San Miguel County Detention Center has been awarded a grant in the amount of \$8,045.00 by the New Mexico Community Foundation. Once a year the foundation awards grants to correctional/detention facilities for gardening programs. With this grant the Detention Center will purchase a hoop house, gardening tools, drip system and the seeds needed to start the program. The gardening program will have an educational component and will be part of the daily programming within the reintegration center. Mr. Elwell requested the Commission review and accept grant by the New Mexico Community Foundation.

# 17. LAS VEGAS/JUVENILE JUSTICE CONTINUUM BOARD CONTRACT

San Miguel County DWI Coordinator Yolanda Cruz informed the Commission the New Mexico CYFD administers the Juvenile Justice grant to local government entities to advocate for the prevention of juvenile delinquency and the provision of a continuum of high quality services throughout the New Mexico Juvenile Justice system by, advising the Governor and the Legislature on Juvenile Justice issues. San Miguel County will have the opportunity to oversee the grant and program immediately to ensure quality program delivery for atrisk youth throughout the county. The approved grant for FY19 is \$30,000 with at least a 40% match required from the County. Ms. Cruz requested Commission approve Juvenile Justice Continuum Board Grant for FY19.

# 18. <u>APPROVE GRANT APPLICATION FOR UNDERAGE DRINKING PREVENTION PROGRAM NMDOT</u>

San Miguel County DWI Coordinator Yolanda Cruz informed the Commission the San Miguel County DWI Program was notified that the NMDOT, Traffic Safety Bureau was seeking to partner with Local DWI programs to combat underage drinking. The San Miguel County DWI Planning Council is seeking \$7,122.80 for each year for 2 years to support environmental strategies around this goal. Ms. Cruz requested the Commission approve of the NMDOT Underage Drinking Application.

### 19. <u>RATIFY FY19 LDWI GRANT AGREEMENT</u>

San Miguel County DWI Coordinator Yolanda Cruz informed the Commission the San Miguel County DWI Program was awarded \$30,000 for FY19 through the LDWI Grant, administrated by DFA. This is in addition to the \$178,079.98 the program will receive in distribution funds. In order to meet deadlines, Chairman Chris Najar signed the agreement. Ratification is requested at this time. Ms. Yolanda Cruz requested the Commission Ratify FY19 Grant Agreement.

# 20. <u>RATIFY MOU BETWEEN EL CENTRO, CITY OF LAS VEGAS, NMHU, HOPE RECOVERY AND SAN MIGUEL COUNTY TO PARTNER ON A HRSA PLANNING GRANT TO SUPPORT SUBSTANCE ABUSE INPATIENT RECOVERY SERVICES</u>

San Miguel County DWI Coordinator Yolanda Cruz presented to the Commission information on the MSG LC4 Local Behavioral Health Collaborative initiative to combat substance abuse. Key partners identified a collaborative HRSA grant that would support the work. El Centro Family Center took the lead in applying for \$200,000. Key partners who signed the MOU are listed above. In addition, we received over 20 letters of support from community entities. Chairman Najar signed the MOU; ratification is sought at this time. Ms. Cruz requested Commission Ratify HRSA Planning Grant MOU.

The funds can be spent on one or more of the following purposes, (1) Conservation of soil and water (2) Control of rodents and predatory animals (3) Extermination of poisonous and noxious weeds (4) Construction of dipping vats, spraying machines, and other construction to control parasites on livestock (5) repair maintenance of said vats, machines and structures (6) Construction and maintenance of secondary roads. Each year the County is required to complete the FRIF Accounting Form to the New Mexico Department of Agricultural Programs and Resources Division of New Mexico State University.

#### 27. RESOLUTION 2018-08-11-F1

San Miguel County Finance Division Supervisor Melinda Gonzales informed the Commission of the final FY18/19 which submitted to DFA system on July 31, 2018. The resolution indicated a transfer of funds to fund 206 for disasters and to Fund 221 for capital outlay for the detention center, the form did not include the expenditure of these funds as well. This budget is to budget the expenditure of the transfers. The county detention center received a grant for Gardening Project with an increase of \$8,054. The road fund 201 had a decrease of \$10,500 and an increase of \$10,500 to Solid Waste Fund 998. A transfer was requested from the general fund 101 to Juvenile Fund 308 in the total \$42,000.
