Motion made by Vice Chairman Arthur Padilla to award the bid to RL Leeder. Second by Commissioner Maria Martinez. Motion carried.

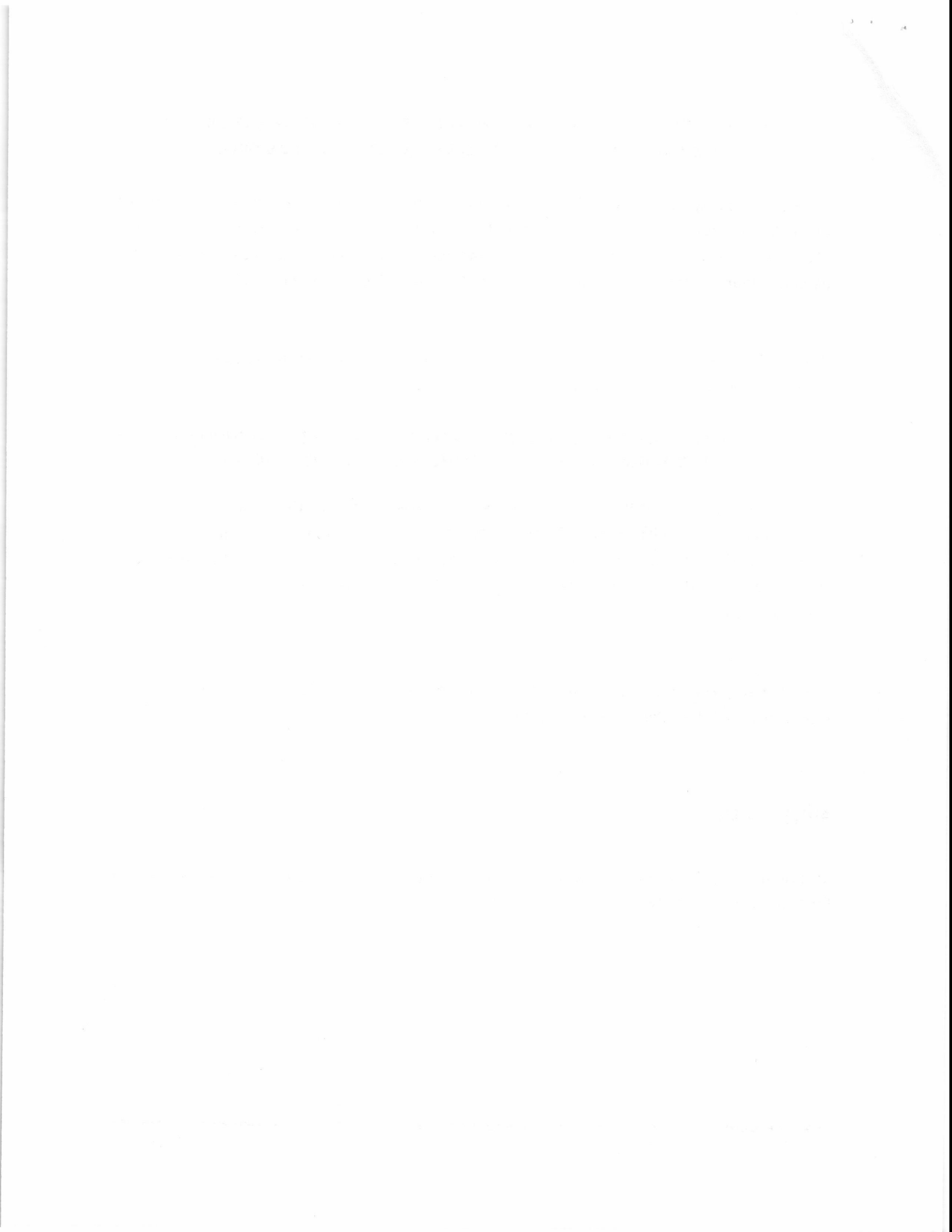


Motion made by Commissioner Chris Najar to award the bid to Rocky Road Gravel. Second by Vice Chairman Arthur Padilla. Motion carried.


