4. <u>FY18 LDWI GRANT AGREEMENT WITH DFA TO FUND THE SAN MIGUEL COUNTY DWI PROGRAM IN THE AMOUNT OF 32,000.</u>

San Miguel County DWI Prevention Specialist Ebeny Mondragon informed the Commission that the NM DWI Grant Council has awarded the San Miguel DWI Program \$32,000.00 for FY18. The original requested amount was \$38,000.00. Although there were no areas of concern in the grant application that was submitted, and it was rated very high, the available funding was lower than previous years.

5. APPEAL OF CONDITIONAL USE PERMIT CU-0245

San Miguel County Planning and Zoning Supervisor Alex Tafoya informed the Commission that at the May 10, 2017 County Commission meeting, the Board of County Commissioners tabled the appeal of Conditional Use Permit CU-0245 until further notice from the New Mexico Department of Transportation (DOT) concerning an application for a junkyard approval submitted to DOT by Mr. Christopher Trujillo. Since that time, San Miguel County has been advised by the Department Transportation that the license for junkyard submitted by Mr. Trujillo not be approved. The matter of the appeal still remains.

San Miguel County Planning and Zoning Supervisor Alex Tafoya informed the Commission that GL Environmental Inc. has indicated that they wish to extend its agreement with San Miguel for professional engineering and consulting services as needed, which agreement provides for technical services to ensure that the requirements of SMC Ordinance No. 11-12-14-O&G are complied with by applicants for conditional use permits for oil and gas drilling and exploration.

This lease is for the property on which the Pecos Canyon Volunteer Fire Department is housed. The lease will expire on June 30, 2018. It is understood that the Brush

Ranch has been sold. At this time, staff is requesting authorization to begin discussions with Mr. Larry Lujan, the new owner, to renew and or extend the lease.

14. <u>REQUEST TO AWARD THE SAPELLO-ROCIADA FIRE STATION IMPROVEMENTS</u> PROJECT

San Miguel County Fire Chief Mike Montano informed the Commission that recently this division advertised a request for Bids for the Sapello-Rociada Fire Station Project. Five bids were received. The lowest most qualified bidder at that time, with a bid of \$74,400.00 was LB Regensberg. The next day, Mr. Regensberg contacted Mr. Kevin Balciar of Soleil West to pull his bid as he believed there was a mathematical error within his bid. Mr. Balciar then recommended the County go with the next lowest most qualified bidder which was EC Salazar with a bid of \$88,000.00. at this time staff is recommending, along with Mr. Balciar, awarding the Sapello-Rociada Fire Station Improvements Project to EC Salazar as the lowest most qualified bidder

San Miguel County Information Technology Supervisor Diego Trujillo informed the Commission that during a routine audit of the San Miguel County Addressing data, it was discovered that there are three or more structures on a single driveway located off Sheridan Rd. As per San Miguel County Ordinance No SMC-07-13-99-ORD-2 Section 4.1-C; it is purposed the San Miguel County Commission please review and take appropriate action on road naming for, "any private road that provides access to three or more buildings and requires a name in order to promote the health, safety and welfare of the public. Letters were sent out to the residents on September 9, 2016 informing them of San Miguel County's intent to change the name. The deadline to submit the petition for the name change was October 14, 2016. None of the three (3) current residents responded within the allotted 30 day period subsequently, the name "Jagged Dr." is suggested as the name for the road. This name has been determined to be acceptable by SMC Rural Addressing staff per San Miguel County Ordinance No. SMC-07-13-99-ORD-2. Because this road naming was required and not requested by the residents, the \$100 fee has been waived. Mr. Trujillo is requesting Review and approval of resolution NO.07-11-17-RA01
