- 1. RESOLUTION NO. 10-13-2016-CM AUTHORIZING THE COUNTY TO SUBMIT AN APPLICATION TO THE NEW MEXICO FINANCE AUTHORITY TO REFUND CERTAIN OUTSTANDING DEBT OF THE COUNTY TO ACHIEVE ECONOMIC SAVINGS AND TO IMPROVE AND REMODEL COUNTY BUILDINGS, INCLUDING THE COUNTY SHERIFF'S OFFICE AND DETENTION CENTER**

County Manager Les Montoya informed the Commission of the discussion of refinancing San Miguel County's existing debt 2007 Bond Series. Daniel Alsup REC Marketing Financial Advisor informed the Commission of the County's refinancing of certain debt to achieve interest cost savings over the life of the debt and to improve and remodel County's buildings including the Sheriff's Office and Detention Center. Mr. Alsup requested the Commission approve the Resolution authorizing the County to submit an application to the New Mexico Finance Authority to refinance existing 2007 Bond Series.

Motion made by Commissioner Padilla to approve Resolution NO 10-13-2016-CM. Second by Commissioner Ortiz. Motion carried.

- 2. RESOLUTION NO. 10-13-2016-CM DECLARING THE COUNTY'S INTENT TO CONSIDER A DEBT ORDINANCE AT A SUBSEQUENT COUNTY COMMISSION MEETING TO REFINANCE CERTAIN OUTSTANDING DEBT OF THE COUNTY AND TO APPROVE BORROWING MONEY FOR NEW CAPITAL PROJECTS, AUTHORIZING COUNTY STAFF TO SUBMIT NOTICE OF MEETING AND INTENT TO CONSIDER ORDINANCE TO THE LAS VEGAS DAILY OPTIC FOR PUBLICATION, AND AUTHORIZING THE COUNTY TO RETAIN A MUNICIPAL ADVISOR AND BOND COUNSEL TO ASSIST THE COUNTY WITH THE REFINANCING.**

County Manager Les Montoya informed the Commission on Resolution No. 10-13-2016-CM declaring the County's intent to consider a debt ordinance at a subsequent County Commission Meeting to refinance certain outstanding debt of the County and to approve the borrowing of money for new capital projects. Mr. Montoya requested the Commission approve the resolution.

Motion made by Commissioner Padilla to approve Resolution NO 10-13-2016-CM. Second by Commissioner Ulibarri. Motion carried.

- 3. STATEMENT OF VACATION-HAWK'S LANDING SUBDIVISION**

San Miguel County Planning and Zoning Division Supervisor Ralph Bustos informed the Commission that Bonnie J McGowan Manager of Hawk's Landing LLC owner of Hawk's Landing Subdivision filed a Statement of Vacation Application-Alteration of Parcel Boundaries. Mr. Bustos informed the Commission that there are (5) lots in this subdivision 12,14,16,17, and 18 these lots are being amended in order to place the roads in open areas, therefore reducing the need to remove a large percentage of the pinon and ponderosa pines.

Mr. Bustos requested the Commission review and conduct a public hearing and approve the request of the Hawk's Landing Subdivision. No opposition was voiced.

Motion made by Commissioner Leger to approve Statement of Vacation- Hawk's Landing Subdivision. Second by Commissioner Ortiz. Motion carried.

- 4. PRESENTATION FROM LISA GRIEGO, SPOKEPERSON FOR THE LOCAL AUTOMOBILE DEALERS**

Lisa Griego spokesperson for the local automobile dealers informed the Commission she was there on behalf of Local Automobile Dealers and was requesting the Commission work on adopting a New Ordinance that would protect Local Automobile Dealers, from outside vendors establishing sales for extended periods of time. These vendors create hardship for local vendors. Ms. Griego informed the Commission she had concerns the County approved a special use permit for a used car sales vendor during a period of time a County moratorium was in effect in the County. Ms. Griego requested the Commission take action based on the actions of County staff.

County Commission advised the matter will be reviewed by the County Manager and County Attorney.

No formal action was taken on this item.

5. APPROVAL FROM SAN MIGUEL COUNTY BOARD OF COMMISSIONERS TO SUBMIT APPLICATION FOR THE ASSISTANCE TO FIREFIGHTERS GRANT (AFG) FY16

San Miguel County Emergency Manager Kurt Parkinson informed Commission of a request to authorize to submit a grant that would create and enhance the safety of the public and firefighters with respect to fire and related hazards by providing critically needed resources to equip and train emergency personnel. Mr. Parkinson informed the Commission the grant is for \$300,000.00 with a 10% match of \$30,000.00. Mr. Parkinson requested Commission authorization to submit grant application.

Motion made by Commissioner Leger to approve the application for the assistance to Firefighters Grant (AFG) FY16. Second by Commissioner Ortiz. Motion carried.

6. BIDS FOR TRI-COUNTY FAMILY JUSTICE CENTER

San Miguel County Planning and Zoning Supervisor Alex Tafoya informed the Commission San Miguel County received two bids for repairs to the Tri-County Family Justice Center for window repairs and drainage problem. Both bids came in over the amount of available funds budgeted for the project. Mr. Tafoya requested the Commission reject both bids and direct County Staff to re-bid the projects.

Motion made by Commissioner Ortiz to reject both bids and direct County Staff to re-bid the projects. Second by Commissioner Leger. Motion carried.

7. APPROVAL FROM SAN MIGUEL COUNTY BOARD OF COMMISSIONERS TO ACCEPT THE FY16 EMERGENCY MANAGEMENT PERFORMANCE GRANT

San Miguel County Emergency Manager Kurt Parkinson informed the Commission the San Miguel/City of Las Vegas Office of Emergency Management is requesting acceptance of the FY16 Emergency Management Performance Grant in the amount of \$65,313.60 with a match of \$65,313.60 for a total of \$130,627.20. Mr. Parkinson requested the Commission authorization to accept the EMPG.

Motion made by Commissioner Leger to approve and accept the EMPG. Second by Commission Ulibarri. Motion carried.

8. REQUEST TO AUTHORIZE ROAD VIEWING

San Miguel County Planning and Zoning Division Supervisor Ralph Bustos informed the Commission San Miguel County received Petition CR 16-006 from several residents of the Big Mesa. The residents are requesting that Yucca Road, Pinon Road, Cactus Road and Cedar Drive be established as public roads and be maintained by County. Mr. Bustos requested the Commission accept these roads as legal public roads.

Motion made by Commissioner Leger to approve the request to authorize road viewing. Second by Commissioner Ortiz. Motion carried.

9. AUTHORIZATION TO NEGOTIATE WITH ENGINEERS TO PERFORM ENGINEERING SERVICES TO COMPLETE COUNTY ROAD IMPROVEMENTS

San Miguel County Grant Writer Alex Tafoya informed the Commission the County has issued a request for County Road and Drainage Projects. Proposal was received from (6) consultants and evaluated and scored by a committee of (5) individuals. The committee determined the top (3) scoring consultants should be considered and recommends contract negotiations should be authorized. Mr. Tafoya requested the Commission consider approving the committee's recommendation to negotiate with the (3) consultants the cost to complete such work. The three companies include Miller Engineering, Occam EI Engineering, and Forsgern Associates.

Motion made by Commissioner Ulibarri to approve the authorization of staff to enter into negotiation with the (3) consultants as identified by staff. Second by Commissioner Padilla. Motion carried.

10. RESOLUTION NO. 10-13-2016-SOLAR PROPOSING AMENDMENT TO SOLAR ENERGY FACILITY ORDINANCE

San Miguel County Planning and Zoning Division Supervisor Ralph Bustos informed the Commission of Resolution No. 10-13-2016-Solar Proposing Amendment to Solar Energy Facility Ordinance establishing fees for the various values of such projects with in San Miguel County. The fees established and proposed we set based on prior fees assessed for such facilities constructed in San Miguel County. Although these projects create temporary construction jobs, the facilities are expected to last (20 to 30) years. The value of these projects are be assessed with the County Assessor's Office, and based on these valuations the County experiences increased property tax revenues for the life of the facility. Mr. Bustos requested Commission approval of the proposed Resolution amending Section 21 of Ordinance SMC-05-10-11-Solar Energy Facilities Ordinance.

Motion made by Commissioner Leger to approve proposed Resolution NO. 10-13-2016-Solar. Second by Commissioner Padilla. Motion carried.

11. 2ND EXTENSION AGREEMENT CONTRACT-CARE OF PRISONER(S)-CITY OF LAS VEGAS, NEW MEXICO AND SAN MIGUEL COUNTY NEW MEXICO

San Miguel County Warden Patrick W. Snedeker informed the Commission the 2nd Extension Agreement- care of prisoner (S) contract, by and between the City of Las Vegas, New Mexico, and San Miguel County, New Mexico, providing for housing and care of City of Las Vegas Municipal Court arrestees, at the San Miguel County Detention Center; is presented for Commission review and approval. The cost of housing is ninety dollars (\$90.00) per day/per inmate. Mr. Snedeker requested the Commission review and approve the 2nd Extension Agreement Contract.

Motion made by Commissioner Ortiz to approve the 2nd Extension Agreement Contract. Second by Commissioner Ulibarri. Motion carried.

12. BID AWARD FOR MAINTENANCE VEHICLE

San Miguel County Grant Writer Alex Tafoya informed the Commission San Miguel County received a 2016 legislative appropriation for funding to purchase a vehicle for the Maintenance Operation Staff. Mr. Tafoya informed the Commission the County received bids from two companies for the purchase of a 2017 Ford Pickup Truck. Mr. Tafoya requested the Commission approve the purchase of a 2017 Ford Pickup for \$29,888.00 from the lowest bidder being Power Ford.

Motion made by Commissioner Leger to approve to award bid to the lowest responsible bidder and authorize County staff to proceed with finalizing the purchase. Second by Commissioner Padilla. Motion carried.

13. APPROVE RESOLUTION 10-13-2016 REQUESTING A 6 MONTH EXTENSION ON THE 15-16 COOPERATIVE AGREEMENT SP-4-16(903) BETWEEN SAN MIGUEL COUNTY AND NEW MEXICO DEPARTMENT OF TRANSPORTATION FOR THE PROJECT IN TECOLOTITO

San Miguel County Public Service Operations Division Supervisor Morris Madrid informed the Commission that San Miguel County Public Services Operations Division and the New Mexico Department of Transportation entered into a Cooperative Agreement SP-14-16(903) in Fiscal Year 15-16. Mr. Madrid also informed the Commission a previous Resolution requesting extension included the wrong funding agreement. The correct Agreement is SP-4-16(903). Mr. Madrid requested the Commission approve Resolution 10-13-2016 and also accept the corrected Cooperative agreement SP-4-16(903).

San Miguel County Warden Patrick Snedeker informed the Commission of the 4th renewal Agreement for the provision of an Inmate Jail Management System/B.O.S.S. Software System; by and between Justice Software, Inc. and the San Miguel County Detention Center. Mr. Snedeker requested the Commission review and approve the 4th Renewal Agreement by and between Justice Software, Inc. and the San Miguel County Detention Center.

Motion made by Commissioner Padilla to approve the 4th Renewal Agreement. Second by Commissioner Ulibarri. Motion carried.

16. CARE OF PRISONER(S) AGREEMENT- COLFAX COUNTY, NEW MEXICO AND SAN MIGUEL COUNTY, NEW MEXICO

San Miguel County Warden Patrick W Snedeker informed the Commission of the Care of Prisoner(s) Agreement, by and between Colfax County, New Mexico and San Miguel County, New Mexico; providing for housing and care of Colfax County inmates, at the San Miguel County Detention is presented for Commission review and approval. The cost for housing is ninety dollars (\$90.00) per day per inmate, with a twenty dollar (\$20.00) booking fee. Mr. Snedeker requested the Commission approve the Care of Prisoner(s) Agreement between Colfax County and San Miguel County.

Motion made by Commissioner Ortiz to approve the Care of Prisoner(s) Agreement. Second by Commissioner Leger. Motion carried.

17. PUBLIC SERVICE DIVISION REPORT FOR THE MONTH OF SEPTEMBER 2016

San Miguel County Public Service Operations Division Road Foreman Arnold Lopez presented his report identifying the road maintenance, construction and crusher production for the month of September 2016. Mr. Lopez informed the Commission that for the month of September 2016 they did not operate much of the crusher due to the Public Service Division employees working on County roads. Mr. Lopez informed the Commission that 1,135 tons and 40 yards of waste were crushed.

San Miguel County Warden Patrick W. Snedeker informed the Commission that San Miguel County solicited competitive sealed proposal (s) from a qualified vendor (s), for the provision of detention center inmate healthcare services/healthcare management services. San Miguel County is requesting for approval to enter into a contract agreement with HCP Systems LLC. Mr. Snedeker requested the Commission review and approve the Detention Center inmate Healthcare Service.

San Miguel County IT Supervisor John Tiernan informed the Commission during a routine audit of San Miguel County addressing data, it was discovered that there are three addressed structures on a single driveway located on NM Highway 283 in Agua Zarca, NM which is causing an addressing problem in the area as per San Miguel County Ordinance No. SMC-07-13-99-ORD-2 Section 4.1-C. Letters were sent out to the residents on August 19, 2016 informing them of the County's intent to name the road. A sole land owner signed a petition and returned a road naming petition indicating their preference for the name "Estancia Ln." This name was determined by the SMC Rural Addressing to be acceptable. Mr. Tiernan requested the Commission review and approve Resolution No. 10-13-16-RA01; addition of Estancia Ln., a newly named private road.

San Miguel County IT Supervisor John Tiernan informed the Commission that during a routine audit of San Miguel County addressing data, it was discovered that there are three addressed structures on a single driveway located on NM Highway 283 near Agua Zarca, NM, which is causing an addressing problem in the area, as per San Miguel County Ordinance No. SMC-07-13-99-ORD-2 Section 4.1-C. Letters were sent out to the residents on August 1, 2016 informing the residents of the County's intent to name the road. The three residents signed and returned a road naming petition agreeing to the name "Adobe Road." This name was determined to be acceptable to the San Miguel County Rural Addressing. San Miguel County IT Supervisor John Tiernan informed the Commission, a resident of Las Dispensas, NM has placed a road naming petition to have a section of what is currently labeled as Forest Road 637, be renamed to Iron Colt Rd. The residents turned in an "Easement Deed for Road" outlining the section of road as easement to Forest Road 637. After receiving permission from the Forestry Service, the road name change was determined to be acceptable to the San Miguel County Rural Addressing staff as per Ordinance No SMC-07-13-99-ORD-2. The resident paid the required fee of \$100.00 for the road naming. San Miguel County IT Supervisor John Tiernan informed the Commission that during a routine audit of San Miguel County addressing data, it was discovered that there are three addressed structures on a single driveway located on County Road A11A in Los Vigiles, NM, which is causing an addressing problem in the area as per Ordinance No. SMC -07-13-99-ORD-2, Section 4.1-C. Letters were sent to the residents on August 24, 2016 informing them of San Miguel County's intent to name the road. The sole land owner signed and returned a road naming petition indicating her preference for the name "Columbine Ln." This name change was determined to be acceptable by the San Miguel County Rural Addressing staff as per Ordinance No. SMC-07-13-99-ORD-2, because this naming was required and not requested by the residents, the \$100.00 fee has been waived. Mr. Tiernan requested the Commission review and approve Resolution No. 10-13-16-RA04, addition of Columbine Ln.

24. RESOLUTION NO 10-13-16-RA05; ADDITION OF CAMINO TESORO; A NEWLY NAMED PRIVATE ROAD TO THE OFFICIAL E-911 ROAD LIST OF SAN MIGUEL COUNTY, NEW MEXICO

San Miguel County IT Supervisor John Tiernan informed the Commission during a routine audit of San Miguel County addressing data, it was discovered that there are three addressed structures on a single driveway located on Gutierrez Ln. in Tecolote, NM, which is causing an addressing problem in the area, as per San Miguel County Ordinance No. SMC-07-13-99-ORD-2, Section 4.1-C. Letters were sent to the residents on July 11, 2016 informing them of San Miguel County's intent to name the road. The deadline to submit a petition for a different road name was August 14, 2016. None of the residents residing on this road responded to the road naming, therefore the addition of "Camino Tesoro" was accepted by the Rural Addressing staff. Because this road naming was required and not requested by the residents the fee of \$100.00 was waived. Mr. Tiernan requested the Commission review and approve Resolution No. 10-13-16-RA05 addition of Camino Tesoro.

25. CONTRACT OF EMPLOYMENT FOR JAIL ADMINISTRATOR-OCTOBER 2016 THROUGH OCTOBER 2018

San Miguel County Manager Les Montoya informed the Commission of the renewal of the Employment Contract for Warden Patrick Snedeker. Mr. Snedeker is up for renewal in October. Mr. Montoya recommended the Commission approve the employment contract for an additional two year period at an annual salary of \$76,702.52.

Motion made by Commissioner Padilla to approve the contract extension for Warden Patrick Snedeker. Second by Commissioner Ulibarri. Motion carried.

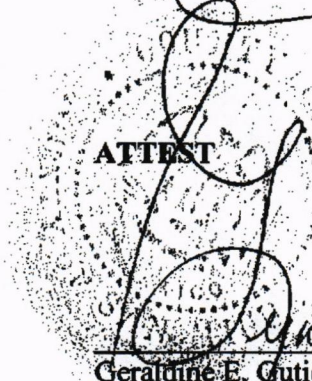
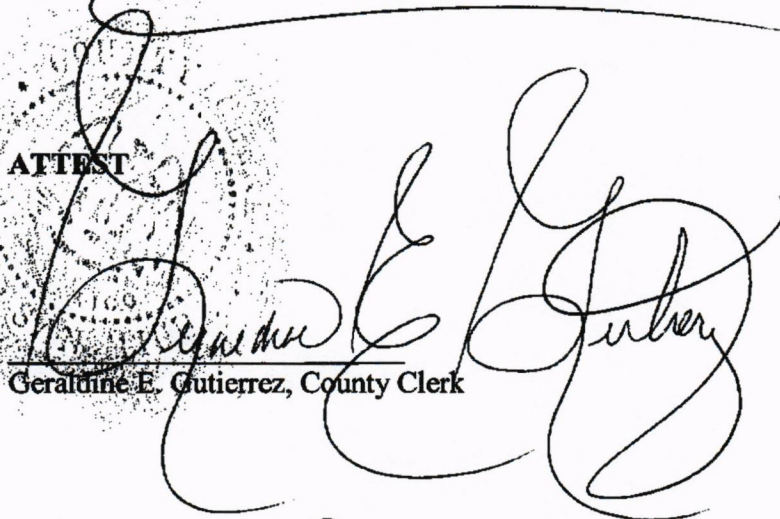

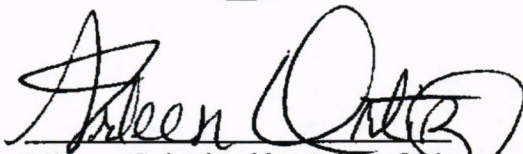
