San Miguel County Public Works Supervisor Gerald Garcia informed the Commission the North Central New Mexico Economic Development Board is asking the Northeast Regional Transportation Planning Organization members to provide Project Prospectus Forms for any new Transportation Projects Fund submittals from the County. Mr. Gerald Garcia turned over the floor to Public Works Foreman Arnold Lopez who informed the Commission that the Legislature approved House Bill 207 which consists of a reoccurring Funding for road projects. Mr. Arnold Lopez requested the Commission select 3 road projects we can receive funding for. Chairman Harold Garcia requested from the Commission 3 road projects the Commission would like to receive funding for: (1) Pendaries, (2) Pecos Projects and the (3) Chapelle/Sheridan/Bernal Project.
