NEW BUSINESS

8. REGULAR ORDER

a. COUNTY MANAGER/DEPUTY MANAGER'S REPORT*

County Manager Joy Ansley informed the Commission on the following:

- * Patterson Wind contacted the Manager's office regarding revising and amending the current County's Wind Energy Ordinance. Manager, Attorney and related parties will meet to discuss.
- * RFP for architectural services has been issued and may be on Agenda for March meeting for approval. * Funding grant was received for the Addiction Treatment Center and NM Council of Governments will assist in grant writing. * Numerous non-profits request funding from Legislative appropriations, monies are then disbursed to the County, and SMC then becomes fiscal agent. Most times the money is received and the County has no idea what it is for as SMC has not been informed by the non-profit that they applied for funding. Manager Ansley is

developing an approval protocol the non-profits will need to follow and to ensure the received funds are funded into its specific line-item. Administratively this will help all parties involved with administering the funds. * Sheriff's Office needs final electric work complete. Voting Machine building should be complete mid-March. Addiction Treatment Center should be complete mid-March. Shooting Range work is on-going with projected completion by March. * Commissioner Sena fielded a call from SFNF Forest Ranger Ancon regarding development of a wood program. Manager's office will contact and arrange a plan of action with the SFNF.

Deputy Manager Jesus Romero informed the Commission on the following:

NMC 2024 Summer Conference planning continues. * KFUN & KNMX community radio show continues. * Continued coordination and assisting in the Assessor's office. * Leadership NM is hosting a Disaster Recovery Workshop. * Human Resources regarding personnel issues.

b. DEPARTMENT HEAD UPDATES

IT Director Kenneth Abeyta informed the Commission the county has been receiving targeted incursions approximately every four days attempting to disable the system. IT Director Abeyta informed the State cyber-security divisions and counties have been informed. County staff is reminded to please verify and question all e-mail received from known/unknown sources and DO NOT CLICK on any links or attachments received.

c. GENE TORRES GOLF COURSE SUBSIDY REQUEST

NMHU President Dr. Sam Miner with Regent Member Mr. Bill Garcia addressed the Commission on the travails of development/subdivision of the Gene Torres Golf Course and thanked the Commission for past support of the Course. The Course was deeply in debt and it has been paid. SMC allocated \$140K along with the City in March 2022 to develop a housing subdivision on the course to attract professors and other professionals to reside in Las Vegas as well as to open the golf course for use by the public. The golfing area has been used and was open for several seasons. The progress on the subdivision (& other development) is essentially non-existent with the exception of an on-site restaurant, Fusion Tacos. The Commission expressed concern about continued funding without any progress realized. Dr. Miner stated that the Board of Regents is committed to keeping the Golf Course to be used as an amenity for and to the Community. A walking path has been established which has eight exercise units along the path. The Regents approved a research study into the proposed development by way of funding a Murphy Study. NMHU is requesting \$60K per year for three years. The Commission asked if NMHU would accept a one year commitment of \$60K with updates to the Commission by NMHU on progress. The MOU will reflect these conditions.

Motion to award NMHU Gene Torres Golf Course \$60,000 for one year with updates from NMHU regarding progress made by Commissioner Max Trujillo. Second by Commissioner Kenneth Medina. Motion carried.

e. NEW JOB DESCRIPTION: DISASTER RECOVERY PROJECT MANAGER

Human Resources Director Eileen Sedillo asked for approval of this newly created position that will assist and manage monies received for disaster recovery from the HPCC fires and floods, and oversee the operations of these projects. The position will seek out Recovery Projects and coordinate with public works foreman and blade operators in addition to various servicing agencies who are operating in the disaster area of the Counties.

h. RECOMMENDATION FOR APPROVAL OF THE PROFESSIONAL SERVICE AGREEMENT WITH HOLCOMB LAW

Total amount being requested is \$321,007 which covers prevention, treatment, planning and evaluation and alternative methods of sentencing/treatment, salaries and benefits, and contract services.

j. QUESTIONS REGARDING POTENTIAL AWARD OF LEGAL SERVICES CONTRACT RELATED TO THE HERMIT'S PEAK/CALF CANYON WILDFIRES*

Manager Joy Ansley asked the Commission for input on the types of questions to pose on the RFP for Legal Services related to HPCC Fires/Floods. How will all potential damages be quantified throughout the County and in conjunction with the damage to Mora County that borders San Miguel. Many components need to be considered in identifying where assistance will be necessary to mitigate further environmental and infrastructure problems: roads, culverts, water safety, hunting and fishing concerns and tourism; as well as the loss of business and personal property tax revenues. The Commission will need to interview the applicants after the evaluation committee conducts its review. Manager Ansley and Attorney Gallegos will discuss issues of conflict of interest.
