1. CALL TO ORDER

b. INTRODUCTION OF ACTING DISTRICT RANGER FOR PECOS & LAS VEGAS*

Mr. Paul Hancock, Interim District Ranger of the USFS, introduced Mr. Shaun Sanchez, Forest Supervisor for the Sangre de Cristo and Jemez mountain ranges, spoke on the USFS determination to work closely with the communities in regards to prescribed burns and continued economic development with outdoor tourism, and; lot allotments, virtual collaring for grazing livestock, road and hazard tree upkeep, and permits for firewood.

c. COUNTY MANAGER/DEPUTY MANAGER'S REPORT*

Manager Joy Ansley informed the Commission on the following matters: *A symposium on the Hermit's Peak/Calf Canyon Fires will be held March 23, 2023 from 9:00AM-3:00PM at NM Highlands University. *NMC Summer Conference 2024 will be hosted by San Miguel County in Las Vegas June 17-21, 2024. County planning committee will assist in set-up of the Conference. Chairman Garcia asked for the City to contribute to this conference as the economic draw is of benefit to the City. *RFP for Ambulance Services was issued and due February 24, 2023.

*FEMA issued directives for Community Disaster Loans for Road repairs. Maximum loan is \$5M, and most often these loans are forgiven after project is completed. *HB 29 Substance Abuse Treatment Programs funded by the opioid settlement agreement. The County will need to testify regarding its budgeting allocation.

Deputy Manager Jesus Romero informed the Commission on the following matters: *DC
Environmental conducted four air quality tests at the Public Health building in Las Vegas. *4-H
Building will have gutters replaced, and a new water line installed. *County Fairgrounds had a
water leak that has been capped off and installing a new water line with a couple of shut-off
spigots to be added. *Legislative priorities outlined and submitted for Sherriff's office, Ribera
Cultural Center and the Treatment Center. *Ongoing reviews of project in Solid Waste with
consultant Bob Lewandowski. *Continued managerial consults with Human Resources on
ongoing personnel issues. *KFUN update and KNMX update. *Bird spikes on administration
building installed. *Assessor's office assistance regarding taxpayers concern. *Planning and
Zoning concerning abatement and condemned property concerns. *Safety director ongoing
proposals to make the County a safer place to work. *Roger's Mortuary conversations
continue regarding disposal of unclaimed corpses in SMC morgues.

Road Foreman Johnny Trujillo informed the Commission that grading of county roads is ongoing. New material has been added in the area known as Las Dispensas. Snow removal is ongoing especially in Pecos area.

Katherine Sanchez informed the Commission that her goal as Finance Manager for SMC is to streamline accounting practices utilizing online practices to minimize paper waste.

Kenneth Abeyta, IT Director, informed the Commission that a new firewall has been installed to protect against hacking. *Sheriff dash cams were installed and new data network system is in place to host the data received. *The Wi-Fi signal at the Public Works facility has been boosted. *New copy machine service contract is finalized for the county with many departments receiving new machines. *Will be attending the Cyber-Security Conference.

h. PUBLIC WORKS PROJECT AND CRUSHER UPDATES*

Public Works Director Benito Romero informed the Commission on the status of Country Acres project completion of June 30, 2023. This may require an extension request. Pendaries is on winter suspension which will be lifted on March 1. Los Vigiles is mostly complete only lacking speed-bumbs and signage. Storrie Project is complete with exception of Engineer's checklist. Sheridan is on winter suspension which will be lifted March 1. Chapelle is on winter suspension and will be lifted March 1. Bernal overlay is complete. San Ysidro, Gallinas and El Llano chip seal is complete. Chico and Harris will be lifted from winter suspension on March 1. 2023 Projects: Tecolote match waiver approved for \$42,000; Blanchard match waiver for \$33,000. San Juan TPF was awarded \$950K; match waiver will be approved for \$47,500. Mechanic services PO has been issued for the County's crusher. Repairs total around \$23K and parts are en-route to SMC.

Public Works Director Romero asked for submissions to add roads to the TPF Road Selection FY-23/24 and to rank the Commissions selections as follows: 1. Camp Luna mill and overlay,

2. Sheridan, and 3. CR B65A, and 4. San Ysidro.

Motion to approve ranked choices – 1. Camp Luna, 2. Sheridan and 3. CR B65A and, 4. San Ysidro to add to TPF Road Selection FY-23/24 made by Chairman Harold Garcia. Second by Vice Chairman Martin Sena. Motion carried.

i-a. MATCH WAIVERS FOR TPF FUNDS

Public Works Director Romero asked for approval of TPF match waivers for TPF funds for \$47,500 for the San Juan project (5% of \$950K project total).

Motion to approve San Juan project 5% match of \$47,500 made by Commissioner Max Trujillo. Second by Commissioner Kenneth Medina. Motion carried.

k. AWARD CONTRACT FOR ENGINEERING FOR EAST PECOS WATER DISTRIBUTION LINE

Alex Tafoya, Consultant to SMC, asked the Commission to approve the RFP/Engineering Services for CBDG# 21-C-RS-i-01-G-50 for a 402 foot water line in East Pecos. Two proposals received: Souder Miller Associates and Souenna Design and Architecture. Souenna did not follow the specifications of the RFP, and Mr. Tafoya recommends the contract be awarded to Souder Miller Associates. The County will act as Fiscal Agent for this project.

Motion to award contract for East Pecos Water Distribution Line to Souder Miller Associates made by Commissioner Max Trujillo. Second by Commissioner Janice Varela. Motion carried.

I. ACCEPT CBDG GRANT NO. 21-C-NR-04-G-91 FOR ECONOMIC DEVELOPMENT GRANT FOR BARELA TIMBER

Alex Tafoya, Consultant to SMC, asked for approval of the CBDG grant for Barela Timber in the amount of \$500K. The environmental review process has been started and Barela Timber needs to inform the Commission on what type of equipment the grant will purchase.

The Commission and County Manager thanked Mr. Tafoya for securing two CBDG grants.

m. AWARD CONSTRUCTION CONTRACT FOR RESIDENTIAL TREATMENT CENTER

County Manager Joy Ansley asked to award and approve the construction contract for Residential Treatment Center. Base bid: \$3,942,000 with additional bids of \$48,000 (fencing); \$102,000 (exterior concrete); \$46,100 (framing); \$7,500 (card readers). These bids are from Franken Construction.

r. RESOLUTION 02-14-23 COMMISSION IN SUPPORT OF REGIONAL FIRE TRAINING FACILITY

City Councilman David Romero presented the Commission with a resolution requesting support of construction/expansion of a regional fire training facility and an emergency response center

at the city airport. This need was highlighted during the Hermit's Peak/Calf Canyon Fire. This facility will serve as a fire retardant facility for the region. Luna Community College, NM Highlands University, SMC, Mora county, and Pecos will all benefit educationally and logisitically.
