CALL TO ORDER AND ROLL CALL

The San Miguel County Board of Commissioners held a special meeting on Tuesday March 30, 2021. San Miguel County Chairman Harold Garcia called the meeting to order at 9:00 A.M., via remote live on San Miguel County website. Upon roll call by the office of the County Clerk's Deputy Arleen Ortiz, Chairman Harold Garcia present, Madam Vice-Chair Janice Varela present, Commissioner Max Trujillo present, Commissioner Martin Sena present, and Commissioner Kenneth Medina not present.

The record will show a quorum is present. Chairman Harold Garcia stated for the record that Commissioner Kenneth Medina was running late to the meeting.

SAN MIGUEL COUNTY PUBLIC WORKS DEPARTMENT- RECOMMENDATION OF AWARD-2021
SAN MIGUEL COUNTY BRIDGE IMPROVEMENTS-TECOLOTE CREEK BRIDGE A-19A
RECONSTRUCTION PROJECT

San Miguel County Public Works Supervisor Gerald Garcia informed the Commission San Miguel County solicited competitive bid(s) from qualified vendor(s) for the reconstruction project on

the Tecolote Bridge. Of the three bids received Franken Construction Company as the lowest responsive bidder. Mr. Gerald Garcia requested the Commission approval to enter into a contractual agreement with Franken Construction Company for the bridge improvement in Tecolote.

Motion made by Commissioner Martin Sena to approve the recommendation to award the Tecolote Bridge Reconstruction Project to Franken Construction Company. Second by Commissioner Max Trujillo. Motion carried.

RECOMMENDATION TO CONTRACT WITH AMERICAN MEDICAL RESPONSE(AMR)

San Miguel County Interim County Manager Melinda Gonzales informed the Commission the City of Las Vegas together with San Miguel County advertised for request for proposals for ambulance services. The County received two proposals and is requesting the Commission first review the draft contract between the City, County and AMR. Second to authorize County Staff and County Attorney to continue to work with the City and AMR to finalize the contract and finally once the contract has been finalized, to allow staff to sign and award the contract to AMR. Ms. Melinda Gonzales requested the Commission review and approve recommendation to contract with American Medical Response (AMR).

Chairman Harold Garcia stated for the record that Commissioner Kenneth Medina was now joining the meeting.

Motion made by Madam Vice-Chair Janice Varela to approve the recommendation to contract with American Medical Response (AMR). Second by Commissioner Max Trujillo. Motion carried.
