1. NATIONAL VICTIMS' RIGHTS WEEK PROCLAMATION

District Attorney Tom Clayton informed the Commission on the proclamation declaring April 18-24, 2021 National Crime Victims' Rights Week. Mr. Tom Clayton informed the Commission on the issues going on in the Community. Mr. Tom Clayton informed the Commission that just this past year since he took office his office prosecuted 1800 new cases. Mr. Tom Clayton requested the Commission approval of the proclamation.

Chairman Harold Garcia requested the Commission approve the request to move the May 2021 Regular monthly meeting to the Village of Pecos.

3. <u>SAN MIGUEL COUNTY HOUSING AUTHORITY (SMCHA) HUD ANNUAL PLAN 2021 AND FIVE (5) YEAR PLAN</u>

San Miguel County Housing Authority Acting Director Betty Valdez informed the Commission on the Comprehensive Guide for SMCHA policies and programs, operations and strategies for meeting local housing

needs and coals. Ms. Betty Valdez informed the Commission on the Foster Youth to Independence FYI vouchers plan. This would assist those youth turning 18 years of age who are aging out of the foster program so that they do not fall into homelessness. This voucher plan will consist of an annual and a five year plan that will serve the needs of the low, very low and extremely low families in San Miguel County. Ms. Betty Valdez requested the Commission approval to work together with HUD and CYFD to create an MOU to assist with this program.

Mr. Andrew Duran requested the Commission adopt Resolution 04-13-2021-Fire Restrictions.

8. PROCLAMATION - MOTORCYCLE AWARENESS MONTH

San Miguel Interim County Manager Melinda Gonzales presented the Commission the proclamation declaring the month of May Motorcycle Awareness Month. Ms. Melinda Gonzales read the proclamation out loud to the Commission. Ms. Melinda Gonzales requested the Commission review and approve the proclamation.

9. <u>NM EMERGENCY RENTAL ASSISTANCE PROGRAM</u>

San Miguel Interim County Manager Melinda Gonzales informed the Commission the Emergency Rental Assistance Program is rental and utility assistance to households experiencing financial hardship due to the Covid -19 outbreak. The Department of Finance and Administration and several partners are developing an online application portal for New Mexicans to apply for assistance at www.RentalHelpNM.org. Ms. Melinda Gonzales informed the Commission of the eligibility requirements to obtain this assistance.

10. <u>AUTHORIZATION TO APPLY FOR A PLANNING GRANT FOR A RODEO COMPLEX</u>

San Miguel Interim County Manager Melinda Gonzales informed the Commission one of Northern New rich traditions has included rodeos. Rodeos are still very popular and well attended. Ms. Melinda Gonzales informed the Commission that the County would like to seek a planning grant for a Rodeo Complex. The planning grants are available through the New Mexico Finance Authority. The staff would work on getting an application

completed. Then upon completion of the application a resolution will be presented to the Commission for approval prior to submitting the application to NMFA. Ms. Melinda Gonzales requested the Commission approve the application for a planning grant.

Motion made by Commissioner Kenneth Medina to approve the application for a planning grant for a rodeo complex. Second by Commissioner Max Trujillo. Motion carried.

11. FAIR HOUSING PROCLAMATION

San Miguel Interim County Manager Melinda Gonzales informed the Commission that each year the month of April is recognized as the month of Fair Housing acknowledgment. San Miguel County recognizes that fair housing is a right guaranteed to all Americans. Entities receiving the Community Development Block Grant Fund are required to further fair housing within their communities by publicizing their commitment to fair housing. One way to acknowledge publicizing fair housing is by proclaiming the month of April Fair Housing Day. Ms. Melinda Gonzales requested the Commission proclaim April 13, 2021as Fair Housing Day.

Motion made by Chairman Harold Garcia to approve Fair Housing Proclamation and acknowledge April 13, 2021 as Fair Housing Day. Second by Commissioner Kenneth Medina. Motion carried.

12. EXIBIT 1-Z CITIZEN PARTICIPATION PLAN

San Miguel Interim County Manager Melinda Gonzales informed the Commission the Recipients (grantees) of Community Development Block Grant funds are required to adopt a Citizen Participation Plan in accordance with the 1987 revisions to housing and Community Development Act. Ms. Melinda Gonzales requested the Commission adopt Exhibit 1-Z Citizen Participation Plan.

Motion made by Commissioner Kenneth Medina to approve the adoption of Exhibit 1-Z Citizen Partnership Plan. Second by Commissioner Max Trujillo. Motion carried.

13. **RESOLUTION NO. 04-13-2021-CDBG**

San Miguel Interim County Manager Melinda Gonzales informed the Commission Recipients (grantees) of Community Development Block Grant funds must adopt certain required federal regulations. Ms. Melinda Gonzales informed the Commission that the compliance with federal regulations is ensured by adopting the following required certifications and commitments: Citizen Participation, Fair Housing, Residential Anti-Displacement and Relocation Assistance, Section 3 and Procurement. The adoption of the Resolution must be by Resolution. Ms. Melinda Gonzales requested the Commission approve Resolution NO 04-13-2021-CDBG.

Motion made by Commissioner Kenneth Medina to approve Resolution NO. 04-13-2021-CDBG. Second by Commissioner Martin Sena. Motion carried.

14. ADDENDUM TO CONTRACT WITH ELITE PEST CONTROL

San Miguel Interim County Manager Melinda Gonzales informed the Commission Elite Pest Control was awarded based off a Request for proposals. The contract was initiated for a one year term with the option to renew three additional years. The addendum is for the sole purpose of extending the contract for an additional year. Ms. Melinda Gonzales requested the Commission review and approve the addendum to contract with Elite Pest Control.

Motion made by Commissioner Kenneth Medina to approve the Addendum to contract with Elite Pest Control. Second by Commissioner Max Trujillo. Motion carried.

San Miguel County Public Works Road Foreman Arnold Lopez presented to the Commission the monthly road maintenance report and blading of all County roads for the month of March 2021.

16. REQUEST TO THE COUNTY COMMISSION SUPPORT A RESOLUTION AMENDING THE CURRENT LEDA ORDINANCE, ECONOMIC DEVELOPMENT PLAN TO INCLUDE THE LANGUAGE OF "CULTURAL FACILITY" AS A QUALIFIED ENTITY FOR THE EL VALLE COMMUNITY CENTER FOR THE ADMINISTRATION OF CAPITAL OUTLAY FUNDS FROM THE ECONOMIC DEVELOPMENT DEPARTMENT, STATE OF NEW MEXICO TO MOVE FORWARD ON A LOCAL ECONOMIC DEVELOPMENT ACT (LEDA) GRANT IN THE AMOUNT OF \$30,000 DOLLARS FOR EMERGENCY ROOF REPAIR

San Miguel County Planning and Zoning Supervisor Robert Archuleta informed the Commission that in 2019, a capital outlay reauthorization was provided to the Economic Development Department, State of New Mexico (EDD) for \$30,000 for emergency repairs to the El Valle Community Center through LEDA. Mr. Robert Archuleta informed the Commission the El Valle Community Center is not owned by the County so therefore in order for the County to support or not support the repairs of this facility, the County will need to amend our LEDA Ordinance to add the language to facilitate the El Valle Community Center. Mr. Robert Archuleta requested the Commission approve or disapprove developing an amendment to the LEDA ordinance in order to accommodate the repairs for the El Valle Community Center.

Ms. Melinda Gonzales informed the Commission that this property is run by the San Miguel County Land Grants. The San Miguel Land Grant has given the Board of Trustees provision to act as a primary management tentative of the property. Ms. Melinda Gonzales informed the Commission this will allow the County to work with Economic Development Department to assist in working on this project.

Motion made by Commission Martin Sena to approve changing the language of the LEDA Ordinance in order for the County to work with Economic Development Department and the El Valle Land Gants to repair the roof of the El Valle Community Center. Second by Commissioner Kenneth Medina. Motion carried.

17. <u>VACATION OF PLAT; RIM ROAD (AKA WAMPUM ROAD) AND CONSOLIDATION OF FOUR (4) LOTS</u>

San Miguel Interim County Manager Melinda Gonzales informed the Commission this item is to be removed from the Agenda until the May 2021 or June 2021 Regular Commissioner Meeting.

18. REVIEW OF HAWK'S LANDING, TYPE 3 SUMMARY SUBDIVISION, PUBLIC HEARING

San Miguel County Planning and Zoning Supervisor Robert Archuleta informed the Commission the County has received an application from Bonnie J. McGowan Hawk's Landing for a Type 3 Summary Subdivision consisting of the addition of four residential lots in a 94.55 acre more or less tract of land owned by Hawk's Landing LLC approximately 3 miles northeast of the village of Pecos, New Mexico.

San Miguel County Chairman Harold Garcia asked if there was anyone present who wished to speak for or against the proposed subject. Chairman Harold Garcia at this time turned the meeting over at 3:44 p.m. to the County Attorney Dave Romero to conduct the public hearing in regards to Hawk's Landing Type 3 Summary Subdivision. San Miguel County Attorney Dave Romero swore in the individuals wishing to speak in favor of the subdivision those individuals being Ms. Bonnie McGowan and Mr. Robert Archuleta.

Mr. Robert Archuleta stated for the record that Ms. Bonnie McGowan has met all requirements needed for subdivision addition. Mr. Dave Romero questioned Ms. Bonnie McGowan in regards to the subdivision: questions such as the location of this subdivision, the benefits of the addition and whether there have been any calls regarding any pros and cons.
