5. APPROVAL OF AGENDA

Commissioner Max Trujillo asked that item "m" Wildfire Resilience Training Center be heard before item "a".

6. APPROVAL OF MINUTES

7. PUBLIC INPUT FORUM

Mr. Manuel Garcia spoke on fiscal responsibility and minimizing fraud and embezzlement in managing indigent funds. Solid waste past-due bills are being caught up. Taxes from big ranches and other outfits need to be paid on time to increase the county coffers. Assessments are important in building proper tax rates. In regards to the Healthcare Study Group, Mr. Garcia recommends that hospitals and healthcare be non-profit.

8. REGULAR ORDER

m. Wildfire Resilience Training Center

Catherine Mann – Ecological Monitoring Program Manager, Staci Matlock – Communications, Crystal Medina – Collaboration, and Shantini Ramakrishnan – Conservation Program Manager of the NM Forest and Watershed Restoration Institute at NMHU with 22 staff members has been conducting fire fuel studies and education in minimizing fire risk. Post fire studies include restoration, erosion control and rebuilding efforts through land-use workshops, watershed and flood-plain restoration. The Resilience Training Center is focused on re-training to maximize burn scar rehabilitation as well as fire training for volunteer units and professional fire crews. Workshops training includes youth for generational continuity.

a. COUNTY MANAGER / DEPUTY MANAGER'S REPORT

Manager Joy Ansley informed the Commission on the following matters:

*There are various construction building projects throughout the county in addition to the various road projects. Franken Construction is diligent in rehabbing the Addiction Treatment Center and has submitted its first payment request. Michael Long Construction is busy rehabbing the Sherriff's office and has also submitted its first payment request. Magnum Construction has received its Notice to Proceed on the Clerk's Voting Storage Center as the building has been delivered. Project work is to begin soon. *The schematic plan for the shooting range is complete. The range is funded through a legislative appropriation. Architect costs are within budget and hopefully work can begin on this project in August. *NM Association of Counties Conference was informative for many who attended. One large concern is Counties being asked to act as Fiscal Agents for numerous non-profits and other NGOs and many counties are adopting policies outlining expectations/legality of such requests, and Manager Ansley recommends SMC consider one as well. *SMC is hosting the 2024 NMAC

Conference and a planning meeting will be held this week to begin planning the 2024 Conference in Las Vegas, NM. *FY-2024 interim budget was submitted to NMDFA. Final budget is due 31 July 2023. *The FY-2024 budget complete, the Finance Department will begin focus on the 2021 Audit and then 2022 Audit.

Deputy Manager Jesus Romero informed the Commission on the following matters:

*Deputy Manager Romero with Kenneth Abeyta, Steven Garcia, Vidal Crespin, Benito Romero and Steven Garcia completed Leadership NM Program Workshop. *Attended NM Counties conference. *Continued communication and coordination with Hermit's Peak/Calf Canyon Claims Operations Manager Clarity Collins. *Attended the NMDFA Federal Grant Matching Webinar Conference. *Roger's Mortuary processed two unclaimed corpses. *Ongoing operations meeting regarding the incoming EagleView software. *New Maintenance Supervisor starts in July, and interim supervisor Richard Rivera has been doing an amazing job. *AMR contract negotiations. *Budget issues discussed with Finance Director Katherine Sanchez. *Radio station show will be held on Thursday and safety and firework issues will be topics.

b. DEPARTMENT HEAD UPDATES

Road Foreman Johnny Trujillo informed the Commission that blading and culvert reconstruction continues in Pendaries/Rociada area including Sabinoso, Cow Creek and the areas affected by the rains. Commissioner Sena asked about A16B being locked. Commissioner Varela requested information on B41A and the road leading up to the old school-house in San Juan – according to Mr. Trujillo and PW Director Benito Romero this stretch of road is not on the county road log. To create this as a county maintained road, the Commission will need to take actions to add to the road log.

County Fire Chief Andrew Duran informed the Commission that the Sheridan VFD [Sapello, Rociada & Gallinas are assisting] is creating a Youth Fire Program this summer from June 26 through July 1. Tactical Rescue Training and fast-water rescue training missions have been attended by members of County VFDs. The Tecolotito Fire Station is a subordinate station to the Sheridan VFD. Rowe Fire Station exists regardless of the rumors, and a new chief has been appointed.

IT Director Kenneth Abeyta informed the Commission about the broadband initiative brought about by ARPA funding. This funding can be applied to the County Fairgrounds Complex and the Public Works facility.

c. RESOLUTION APPOINTING THE BOARD OF REGISTRATION MEMBERS FOR SMC AND DESIGNATING THE LOCATION OF POLLING PLACES FOR STATEWIDE ELECTIONS CONDUCTED IN 2024 AND 2025

Chief Deputy Clerk Louanna Ortega asked for approval of appointment of Board Members of the Registration. Tecolote will now be a VCC. All polling locations in SMC are now VCCs.

d. PROPOSED CONTRACT WITH AMR FOR AMBULANCE SERVICES

Manager Joy Ansley informed the Commission on specifics with the AMR/SMC ambulance contract for four trucks (three in LV, one in Pecos) asked price was \$1.8M, and final base price of contract came out to \$1.4M. 60/40 split in favor of SMC at 40%. Village of Pecos contribution is set at \$60K/yearly. This contract is for two years.

RHS proposal was in compliance with the parameters outlined in the RFP. Warden Padilla asked for approval to enter into contract negotiations with Roadrunner Health Services.

h. ROWE FIRE DEPARTMENT CONGRESSIONAL DIRECT SPENDING APPROPRIATION

Chief Andrew Duran asked for approval to finalize the grant received by the Rowe VFD which has a cap of three years for spending. The three years allow the County to secure additional funds to purchase a fire engine. A water tender is on order.

i. RESOLUTION TRANSFERRING SECTION 8 VOUCHER PROGRAM FROM SMC TO NORTHERN REGIONAL HOUSING AUTHORITY

Manager Joy Ansley asked to transfer Fiscal Agent authority from Bernalillo County to Northern Regional Housing Authority for SMCs Section 8 Housing Voucher program. SMC is grateful to Bernalillo County for administering the program these past several years. NRHA has an office in Las Vegas.

Chairman Harold Garcia asked for support in finding solutions to reducing stray animals roaming the County which presents a hazard to citizens, livestock, other pets and property. The County and City need to come to an understanding that this is a problem in our county/city that needs to be addressed to curb strays and other animal welfare/control issues in SMC.

Manager Joy Ansley informed the Commission that the FY-2024 budget for HUD is not complete, and asked for a special meeting before June 30, 2023 for approval.

n. EAGLEVIEW MASTER SERVICES AGREEMENT

Deputy Manager Jesus Romero informed the Commission the high-resolution imaging capabilities of EagleView will be a wonderful addition in assisting the Assessor's office in assessments, building and structure count, and code enforcement. The total cost of the software will be \$2.2M over the life of the six year contract. Each payment will be \$367K. Manager Ansley recommended this item be tabled until further investigation of budget concerns and contract specifics can be researched and finalized.

o. HPCC FIRE RECOVERY LOAN AGREEMENT

Public Works Director Benito Romero informed that two projects have been approved by FEMA for road recovery projects due to burn scar and flooding: Hermits Peak North roads/bridges totaling \$9,456.057; and Pecos area roads totaling \$7,896,534. The two projects total \$17,152,601. Additional Recovery Loan Agreements are forthcoming based on FEMA approval for the various road/bridge damages sustained throughout burn scar-flood zone area. Total estimated road recovery projects will be nearly \$62M.

p. RESOLUTION SUPPORTING NATIONAL LAB REGIONAL TAX DISTRIBUTION STUDY FOR LANL

Chairman Harold Garcia supports this resolution to encourage Los Alamos National Laboratory to extend to surrounding counties subsidies to encourage economic development and science/math programs since the Lab has a multi-billion dollar budget that draws on the resources of not only Los Alamos county but all nearby counties. The purpose of this resolution for the tax distribution study aims to encourage LANL to be integral in building economic and

educational development throughout northern New Mexico, as the resources to sustain LANL are sourced throughout northern New Mexico.
