MINUTES of The SPECIAL MEETING

HELD OCTOBER 21, 2022 AT 9:00 AM

1. CALL TO ORDER

The San Miguel County Board of Commissioners held a special meeting on Friday, October 21, 2022. San Miguel County Chairman Harold Garcia called the meeting to order at 9:00 AM in the in the San Miguel County Commission Chambers at 500 W. National Ave Suite 201. Zoom link is active.

2. ROLL CALL

Upon roll call by Sr. Deputy Clerk Jacob Gonzales: Chairman Harold Garcia present, Vice-Chair Janice Varela present, Commissioner Max Trujillo present, Commissioner Martin Sena present via Zoom, and Commissioner Kenneth Medina present.

The record will show a quorum is present.

3. PLEDGE OF ALLEGIANCE

Commissioner Kenneth Medina led the Pledge of Allegiance and the Salutation to the New Mexico State Flag.

5. APPROVAL OF AGENDA

County Manager Joy Ansley and no commissioner indicated changes to the Agenda.

Motion made by Vice-Chair Janice Varela to approve Agenda. Second by Chairman Harold Garcia. Motion carried.

EXECUTIVE SESSION

Limited Personnel Matters, as permitted by NMSA 1978, Section 10-15-1(H)(2) (as amended) of

the Open Meetings Act, more specifically personnel matters regarding specific county

Departments:

(H)(6) County Attorney Contract -- that portion of meetings at which a decision concerning purchases in an amount exceeding two thousand five hundred dollars (\$2,500) that can be made only from one source is discussed and that portion of meetings at which the contents of competitive sealed proposals solicited pursuant to the Procurement Code are discussed during the contract negotiation process. The actual approval of purchase of the item or final action regarding the selection of a contractor shall be made in an open meeting.

Motion to enter Executive Session made by Commissioner Kenneth Medina. Second by Commissioner Max Trujillo. Executive Session was entered into at 9:04 AM.

Motion to exit Executive Session and reconvene Regular Session made by Chairman Harold Garcia with discussion only on the item while in Executive Session – no action taken. Second by Commissioner Kenneth Medina. Motion carried. Regular Session reconvened at 9:29 AM.

NEW BUSINESS

6. REGULAR BUSINESS

a. CONSIDERATION OF COUNTY ATTORNEY CONTRACT

County Manager Joy Ansley informed that the decision to award the County Attorney contract needs to be made in the form of a motion. Commissioner Max Trujillo recused himself due to business/personal relationship. The Commission thanked the candidates for their time and effort in presenting to the Board.

Motion to award County Attorney Contract to Herman "Chico" Gallegos made by Commissioner Kenneth Medina. Second by Vice Chair Janice Varela. Motion carried.

b. CONSIDERATION OF STAFF INCREASES

County Manager Joy Ansley referenced attention to the spreadsheet derived from the Classification & Compensation study conducted last year intending to bring many positions to the mid-point salary average. The raise to get to mid-point would be at 25%, but awarded

12.5% to fall within the budgeted \$500K that was set-aside for raises. The raises for the study comes in around \$443K leaving approx. \$57K left for raises, as budgeted. Commissioners expressed concern that many positions are being payed well-above the recommended classification, and too many fall below it, and how can that be remedied is a concern? Commissioners raised concerns that merit and performance are not considered when granting raises and feel that this allows for greater turn-over of well qualified employees. Other metrics to audit work performance should be researched. Exempt employees should undergo a separate review process as some Commissioners think they are well compensated at this point. This study places a monetary value on specific position(s) based on neighbouring counties and averages for specific position(s).

Motion to adopt the raises recommended at the 12.5% created by the study made by Commissioner Max Trujillo. Vice Chair Janice Varela made a point of order by indicating that she had made an earlier motion that was not seconded. Commissioner Kenneth Medina stated a comment that there ought to be a scale in which raises are issued in reference to high salaried exempt employees in fairness to the lower waged staff. Chairman Harold Garcia indicated concern on staff morale in the distribution of wages, and that staff should be progressive in their work efforts and to reward positive evaluations. After discussion of when initial motion was made, Commissioner Max Trujillo added to the Motion a caveat that performances must be evaluated and directed County Manager Ansley to determine which direction to head after hearing these comments. Second by Vice Chair Janice Varela. Motion carried.
