8 Regular Order

a. COUNTY MANAGER'S REPORT*

County Manager Joy Ansley informed the Commission of two Request For Proposals for Legal Services and Architectural Services with deadline for submittal August 13, 2021; and a Special Meeting to award RFP will be held on August 17, 2021.

The NM Counties Summer Conference will be held September 22-23 in Hobbs, and invited Elected Officials and Department Heads to contact her office for registration and hotel assistance.

County Manager met with a citizen taxpayer who assisted in developing a Broadband Utilities Special District in Georgia and offered assistance to San Miguel County to establish such district. Mr. Cordova informed and will forward information to Manager Ansley about a Broadband Systems Conference being held in Houston in September. Commissioner Max Trujillo expressed an interest in attending; and spoke on the importance of building technical infrastructure to complement business and education opportunities in San Miguel County.

Manager Ansley informed there are over \$1.7 million outstanding accounts in Solid Waste receivables. Constructs in next steps to collect are being reviewed.

Manager Ansley informed the commission about Hispano Chamber's on-going efforts in clean-up of Kings Stadium. Mr. Martinez requested additional funding to remove trees from the area. The Commission feels that this is unnecessary and the Land Grant should be contacted for further action/direction.

e. POSSIBLE NAME CHANGE TO FLYING DIAMOND SCHOLARSHIP

County Manager Joy Ansley presented changing the name of Flying Diamond Scholarship and indicated that there are no legal hurdles in re-naming, County Attorney Dave Romero, Jr. affirmed. Commissioner Martin Sena recommended the name change be Flying Diamond Manuel "Manny" Villanueva Memorial Scholarship. Mr. Villanueva was a long-time counselor and coach for West Las Vegas Schools. His daughter, Julie Ann Villanueva-Barela spoke on her father's contribution to the education efforts in El Valle and thanked the Commission for considering the memorialization.

Motion made by Commissioner Kenneth Medina to initiate the name change. Second by Commissioner Max Trujillo. Roll call: all commissioners voted in the affirmative. Motion carried.

b. DEPARTMENT HEAD UPDATES

County Manager Joy Ansley informed the Commission that this Update by Department Heads will be a standing Agenda item to allow Department Heads and Elected Officials to address concerns and updates to the Commission if no agenda request was submitted.

Manager Ansley introduced the newly hired Emergency Manager Dennis Esquibel who thanked the Commission and is looking forward to his employment with the County.

Public Works Director Gerald Garcia informed the commission: 1. reiterated outstanding Solid Wastc receivables. 2. Progress of the Cinder Road project and that the Engineer will assist in tweaking the application which is due sometime in September. 3. The Tecolote Creek project is moving forward, however, cost of material/shipping is presenting obstacles. 4. LGRF San Ysidro and Chapel chip-seal, and future projects as well as LTAP. 5. Public Works is awaiting word from the NM Dep't of Transportation match-grants for various funding requests. 6. PW machine operators work very hard for SMC.

Finance Director Melinda Gonzales informed the Commission that \$300,000 will be set-aside for miscellaneous General Fund obligations, but only afforded \$150,000 to maintain cash-reserve rules. Budget has been recorded and forwarded to NM-DFA.

c. ICIP PRIORITIES

Manager Joy Ansley informed the Commission that deadline for submissions is September 17, 2021. Removing County Clerk storage, Sheriff's Dep't building and data/lapel cameras, emergency vehicles, Assessor's spectrometry, Public Works Heavy Equipment as they were funded in FY22 budget. Commission expressed improvements or new buildings for the Fire Departments in Gallinas, Tecolotito, San Jose, and San Ignacio. Fire Chief Andrew Duran indicated that the Department is well-equipped, and is seeking a grant for minor equipment updates.

The Commission would like to add a Drug Treatment Center to the ICIP.

Continuous road improvement projects to be added to ICIP and to retain current road projects on ICIP and seeking \$5 million (Country Acres, Camp Luna; East Pecos low-water crossing, B65A, and county road along the acequia in East Pecos; La Ardiente road; Sabinoso Road and Trujillo Road and road in Pendarie; research on adding speed-bumps in residential areas in District 4 rural areas to ensure public and property safety.)

Warden Padilla asked for improvement on the parking lot at the Detention Center.

Public Works Director Gerald Garcia asked for Cinder Road project be included, as the scope of the project is increasing as are costs for materials/supplies.

d. SET PUBLIC HEARING DATES FOR MINING ORDINANCE

County Manager Joy Ansley informed the Commission that this ordinance has a requirement of at least one Public Hearing with a Public Notice of two weeks prior -- a publish date of Friday, August 13, and the date of hearing be after August 27; Commission set the meeting for the week of the 30th and set it as an action item, Manager Ansley will coordinate the set-up of the Public Hearing and inform interested parties and the Commission on date selected. The Open Hearing will be held in Pecos in the evening as the mining project is in Terrero. County Attorney Dave Romero, Jr., informed the Commission that enacting the Ordinance is important and should be done quickly – the ordinance can be amended after enacted. Attorney Romero indicated the Mining Ordinance does not need Planning and Zoning review as there have been approximately 8 reviews and drafts with various experts and other counties.

f. PROPOSED REAL PROPERTY LEASE WITH STATE OF NEW MEXICO FOR EPI DURAN BUILDING

County Manager Joy Ansley delivered specifics of the lease for the Crisis Treatment Center: \$1 per year lease fee, utilities, and capital or maintenance projects paid for by lessee. The Commission will seek Capital Improvement funds for building improvements. Sublet is not an option.

Motion made by Commissioner Max Trujillo to approve the Lease with State of New Mexico for the Epi Duran building (3112 Hot Springs Blvd, LVNM) to be used as Crisis Treatment Center. Second by Commissioner Martin Sena. Motion carried.

g. DONATION OF MATERIAL TO MORA COUNTY FOR WORK ON MORPHY LAKE ROAD

County Manager Joy Ansley received a request for a donation of seven belly-dumps of crushed material for sealing and emergency patching of Morphy Lake Road in Mora County. Public Works will need a time-frame to crush and Mora county will pick-up materials and manage the project work. The Commission feels this is a neighborly thing to do and it will serve SMC residents in their recreation activities at Morphy Lake.

Motion to approve donation of material to Mora county made by Commissioner Kenneth Medina. Second by Commissioner Max Trujillo. Motion carried.

h. RESOLUTION NO 2021-07-30- SALE OF PROPERTY (2008 INTERNATIONAL FIRE ENGINE)

Fire Chief Andrew Duran informed the Commission the County is in the process of purchasing a new fire apparatus for the Rowe Volunteer Fire Department. During these discussions the idea emerged that the Rowe VFD is not using its 2008 International Fire Engine and could be used as a trade-in for the purchase of new equipment. Chief Duran requested approval from the Commission to declare the 2008 International Fire Engine as excess property and authorize the County Manager to trade said property as allowed by NM State Statute Annotated 1978. Approved Resolution will be sent to the NM State Auditor and Local Government Division as required by law – Fair Market Value determined by the County Finance Director and approved by NMSA/LGD. Manager Joy Ansley found comparable values ranging from \$13,900, and that valuation is lost by 50% in 5-7 years, and believes the trade-in value will be several thousand dollars.

i. PUBLIC WORKS DIVISION REPORT*

Public Works Road Foreman Arnold Lopez presented to the Commission the monthly road maintenance report and blading of all County roads for the month of July 2021. County grader operators have been repairing the washouts from the recent rains and flooding throughout the County. Crushing, pothole repair and chip-seal is on-going throughout the County. Commission commended the Public Works department on their efforts at the SMC Fairgrounds.

j. ADOPTION OF RESOLUTION NO. 081021-P&Z IMPLEMENTING REGULATION OF RECREATIONAL AND MEDICAL CANNABIS PRODUCTION; PERSONAL USE IN SAN MIGUEL COUNTY

Planning and Zoning Supervisor Amanda Salas implemented previous discussions to write this Resolution in issuing hemp and medical cannabis production licenses and its various methods of production and sales in following State parameters of the Cannabis Regulation Act 2021 and of the Lynn and Erin Compassionate Use Act 2007, creating a Cannabis Regulatory Advisory Committee and Fund, and utilizing and enhancing SMCs existing Land Development Standards Ordinance in adopting above Resolution. Public Input from Mr. John Sedillo, a currently licensed hemp producer, spoke on the ethics and need for regulation in this emerging market and to honor local communities concerns and apprehensions in growing this economic development.

County Attorney Dave Romero Jr. informed the Commission that the Resolution is true to legal form and can be amended to ensure the ability to change with developments in implementation of this Resolution.

Motion to adopt Resolution #081021-P&Z Implementing Regulation of Recreational and Medical Cannabis Production; Personal Use in San Miguel County made by Chairman Harold Garcia. Second by Commissioner Kenneth Medina. Motion carried.

k. REQUESTING TO APPROVE MR. SEAN MEDRANO AS PLANNING & ZONING COMMISSIONER, BOARD OF ADJUSTMENT TO FILL THE FINAL VACANCY ON THE PLANNING AND ZONING COMMISSION, BOARD OF ADJUSTMENT

Planning & Zoning Supervisor Amanda Salas asked for approval to appoint Mr. Sean Medrano, a local business owner of Northeastern Construction and of Any Distressed Properties LLC, father and husband, and of local descent.

Motion to approve appointment of Mr. Sean Medrano as a commissioner of the Board of Adjustment P&Z Commission made by Commissioner Max Trujillo. Second by Commissioner Kenneth Medina. Motion carried.

I. ROAD VIEWING IN THE VILLAGE OF VILLANUEVA, NEW MEXICO AS PER ROAD PETITION REQUEST BY MR. GILBERT ORTIZ

Planning & Zoning Supervisor Amanda Salas asked for approval/disapproval of the application submitted on June 7, 2021 by Mr. Gilbert Ortiz for adoption of an unnamed road to be a public road and request maintenance of road by SMC in Villanueva. 50 citizens living within two miles signed a petition requesting such action be taken by the Commission. The P&Z recommends a road viewing to verify length, condition and location of the road. County Attorney Dave Romero Jr. indicated the process for a road viewing can take place, and if there are legal concerns they will be raised in determining whether to adopt the road petition.

m. CONTRACT FOR DETAINEE CONFINEMENT TO HOUSE SAN MIGUEL COUNTY DETAINEES IN COLFAX COUNTY

Warden Antonio Padilla asked for approval by the Commission of the contract to house detainees in Colfax County. Capacity in the SMC Detention Center is 120 inmates. Should capacity exceed 120, SMC needs to transport to house detainees in Colfax County at a cost of \$95 per day per inmate.

Motion to approve Detainee Confinement to House San Miguel County Detainees in Colfax County Detention center made by Vice-Chair Janice Varela. Second by Commissioner Max Trujillo. Motion carried.

n. CONTRACT FOR DETAINEE CONFINEMENT TO HOUSE COLFAX COUNTY DETAINEES IN SAN MIGUEL COUNTY

Warden Antonio Padilla asked for approval by the Commission of the contract to house detainees of Colfax County. Colfax County asked for housing overflow at a charge of \$95 per day per inmate plus a \$20 booking fee. Warden Padilla capped the amount at 5 beds.

Warden Antonio Padilla asked for approval of renewal of Agreement with CorrHealth for medical and behavioral health services provided to the San Miguel County Detention Center for a period of one year. Commissioners asked if the Warden was pleased with services provided, and Warden Padilla indicated CorrHealth is committed to meet requirements and expectations of Agreement.

Chairman Harold Garcia asked County Attorney Dave Romero Jr. to swear in the interested parties who will be speaking to and informing the Commission on LEDA requirements to become Fiscal Agent for El Valle Community Center for the \$30,000 funded in FY22 budget. Two witnesses took the oath, Tim Hagemann of NM Economic Development Department, and Eva Artschwager, Executive Director of the Library and El Valle Community Center.

Mr. Hagemann informed the Commission to fund El Valle Community Center through a LEDA ordinance by considering a first rating of a LEDA ordinance; a draft of a Participation Agreement as well as an inter-governmental agreement. Included in the agreement is a Security Instrument to ensure the funds are used as intended and as protection of the County's investment as the Fiscal Agent for the El Valle Community Center. Fiscal Agent fees range from 3-5%. These funds will be used to repair roof and other drastic structural improvements of existing facilities. Further architectural studies are needed and funding will be sought.

Eva Artschwager informed the Commission that El Valle Community Center in Villanueva serves about 1,500 citizens in El Valle area with direct services in online and real-time education opportunities with 60 programs in education and over 360 students attended these workshops. 15 people were employed part-time by the Centers. Community Farmers Market and other cultural activities enhance the culture of El Valle. Food drives, school supply drives and Christmas Gift drives are other programs that assist needy citizens in El Valle area.

Attorney Dave Romero Jr. asked for additional input from the public on this Ordinance; no one came forward; and asked for adjournment of the Public Hearing on LEDA Ordinance El Valle Community Center. Motion to adjourn Public Hearing and re-adjourn Regular Meeting made by Commissioner Kenneth Medina. Second by Commissioner Martin Sena. Motion carried. Regular meeting entered into at 3:58 PM.
